## Chief's Report

The Chief reported that there were 8 fire calls for the month of February, bringing the year-to-date fire calls to 35, and the total year-to-date activities to 63. The Chief reported that they

had a garage training class /beefsteak in Bloomingdale for those who signed up. There will be bowling on Sundays for the month of March. March 20<sup>th</sup> is the NEMA meeting in Butler and March 24<sup>th</sup> is the Bloodborne Pathogens at 7:00 PM at the Pine Brook Fire Department. There is a drill scheduled for April 22<sup>nd</sup> on reading meters. Pine Brook has updated their run cards and if they go to a second alarm for a structure fire Montville will go to the scene. Commissioners asked if there was any resolution to the moving of the abandoned vehicle at station one. Chief to check into this. Chief requested the removal of probationary member Tyler Marzet; on a motion made by Commissioner Crownover and seconded by Commissioner Luciano and passed unanimously the Commissioners approved the request following the guidelines as stated in the by-laws of the department. Motion to accept the Chief's report was made by Commissioner Crownover; seconded by Commissioner Cook and carried.

## Fire Official's Report

Fire Official Cowley said that there were 7 home inspections in February and 27 inspections of LHUs and registrations. Second round of invoices sent for past due registration payments. New Fire Inspector Sal Farhan has started training. Fire alarm issues that were on going at the youth center have been resolved. Fire Official requested a garage door opener and a gas card for the new car. Thanked the Commissioners for approving the purchase of the car. Fire Official Cowley has resigned his job in Hackensack and will be spending more time in Montville. The credit card acceptance for the department is being finalized. Need to order an IPad as well as follow up on the air card for the tablet. Need to add Knox access for Fire Inspector Farhan. Motion to accept the Fire Officials report was made by Commissioner Luciano; seconded by Commissioner Cook and carried.
